- Communicate between home and school through notices, newsletters, text, email and the school website.

School will create a test and trace system to easily identify close contacts

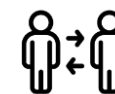
Parent

To help my child at school, I know and understand that:

- If my child, or anyone in my household, shows symptoms of COVID-19 - I will not send them to school.
- I will get them tested and follow the government advice and I will let the school know the outcome as soon as possible - evidence will be required
- If my child shows symptoms of COVID-19 at school, I will collect my child from school immediately.
- When dropping off and picking up I will:
 1. Not drive onto Atkinson Street - park and walk;
 2. Follow the social distancing requirements;
 3. Observe the signed routes around the school site;
 4. Stick to the school timings;
 5. Stay with my child until they are called into class;
 6. Leave the school site promptly.
- My child must not bring any items into school that have not been requested.
- If my child presents as unwell I understand their temperature will be taken.
- I will need to remind my child about social distancing rules but accept they are difficult to follow and that my child may not always do this successfully.
- I will not be allowed into the school without a pre-arranged appointment
- I need to support all staff in their efforts to create an 'as safe as possible' environment at all times.
- Read all letters/messages/emails that are sent home.
- I need to inform the school immediately of any changes to parents/carer and emergency contacts details.
- I am responsible for following guidance outside of school that will keep my family safe and prevent the spread of Covid-19

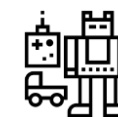
I will do my best to:

- *A rash*
